SPIROMETRY (PFT) TESTING

A spirogram is a cardio pulmonary test that is a valuable tool for evaluating the respiratory system of workers who may have been exposed to asbestos, silica and/or coal dust.

These tests, required under section 40 of the OH&S code, need to be done within 60 days of worker exposure to asbestos, silica or coal dust and then every two years thereafter.

All ACESO Medical spirometry tests are performed by our qualified team of provincially certified pulmonary function technicians who are held to the highest professional standards. Test records are maintained free of charge in our cutting edge secure database.

X-RAYS
